We hereby inform you of the following:

**Data controller:**

**Processing operations and purposes**

The controller wishes to inform you that your company name and the personal and identification details of the contact person who deals with our company will be collected and processed for the following purposes:

- a) performance of pre-contractual and contractual services relating to the ongoing relations between the Parties;
- b) performance of administrative/accounting formalities (including regulatory obligations);

Processing conducted through the use of hardcopy/electronic instruments do not involve the use of automated decision-making processes.

**Legal basis of the processing**

The processing is carried out based on the existence of a contractual relationship between the Data Controller and the Data subject and, in any case, data processing is necessary for fulfilling the legitimate interest of the Data Controller.

**Provision of data**

The provision of data is optional but it is necessary for fulfilling the above mentioned purposes and failure to provide data will make it impossible for us to accept any obligations towards you.

**Communication of data and scope of disclosure**

Data will only be processed by parties who are expressly authorised by the Controller or by parties acting in the capacity of independent controllers or processors, on behalf of the controller itself and who have signed a specific contract governing in detail the respective processing operations entrusted to them and the data protection obligations. By way of example, data may be communicated to the following categories of parties whom the controller uses for certain activities connected to the running of its business: accountants for accounting/tax requirements; banks for payments; law firms in the event of disputes; government authorities for communications required by law. Data will not be disclosed.

**Retention time**

Data will be retained for the period of time that is necessary for fulfilling the above purposes in accordance with contractual and legal provisions, without prejudice to different regulatory provisions.

**Rights of Data subjects**

You are granted and guaranteed the full right to: ask the Controller to access your personal data and amend or erase these or limit or object to processing, aside from your right to portability. You may exercise your rights by sending an email to [amministrazione@savercompositi.com](mailto:amministrazione@savercompositi.com)

Moreover, the Controller will suspend processing operations as soon as it receives a request from you accordingly.

**Complaints to supervisory authority**

Data subjects have the right to present a complaint to the Supervisory Authority in the event of unsatisfactory responses to requests for information from the Controller.
